OSC Exec Appointments

Background

In the 2007-08 academic session the OSC attempted a number of aborted attempts at arranging an AGM and elections for the 2008-09 committee, none of which resulted in either and AGM or any elections. As a result, there is currently no-one in place to run the OSC for 2008-09.

It is absolutely imperative that there is a fully functional OSC committee before the start of term as this CSC has historically been poorly managed and getting a committee in place is the only way of improving this.

The possibilities of organizing an AGM during the summer holidays are essentially zero as most club officers are at home, and particularly in the case of the OSC, are abroad with no chance of coming to attend an AGM in London.

In order to have a committee in place for the start of term, Exec is asked to appoint from the candidates available, the OSC committee for 2008-09.

Positions available and Job Descriptions:

- 1. Officers
 - 1.1. The Officers of the Board shall be the:
 - 1.1.1. Chair,
 - 1.1.2. Honorary Secretary,
 - 1.1.3. Honorary Junior Treasurer,
 - 1.1.4. Assistant Junior Treasurer
 - 1.1.5. International Night Chair
 - 1.2. No person shall hold more than one officer post. Officers hand over to their successors on the 1st of August.
 - 1.3. Officers shall be *ex-officio* members of all OSC societies and shall, if necessary and at the discretion of the Chair, be appointed as stand in President or Treasurer of these societies, should the position be vacant.
- 2. Job descriptions and responsibilities
 - 2.1. The Chair shall:
 - 2.1.1. Represent the OSC and chair its main and executive committees.
 - 2.1.2. Be responsible to the Union President through the appropriate Deputy President for the finances, health & safety, adherence to policy and activities of the OSC and its clubs and societies.
 - 2.1.3. Be responsible for the efficient organisation and administration of the OSC.
 - 2.1.4. Chair the Sub-Committees in the absence of the respective sub-committee chair.
 - 2.1.5. Represent the committee at any formal or ad hoc Union or College committees or meetings which may be of importance to the OSC.
 - 2.1.6. Negotiate other duties with officers.
 - 2.2. The Secretary shall:
 - 2.2.1. Be responsible for the efficient administration of the OSC

- 2.2.2. Prepare minutes of the main and executive subcommittees.
- 2.2.3. Maintain and develop the OSC website.
- 2.2.4. Be responsible for promoting and advertising the OSC within Imperial College Union.
- 2.3. The Honorary Junior Treasurer shall:
 - 2.3.1. Be responsible to the Chair for the efficient administration of the finances of the committee
 - 2.3.2. Organise weekly Treasurers' meetings.
 - 2.3.3. Deputise for the Chair in his or her absence.
 - 2.3.4. Be responsible to the committee for the efficient administration of the finances of the Clubs and Societies.
- 2.4. The Assistant Junior Treasurer shall:
 - 2.4.1. Be responsible for observing the efficient spending of monies granted to the clubs of the committee
 - 2.4.2. Produce a monthly report summarising activity.
 - 2.4.3. Assist the Honorary Junior Treasurer with their task of writing out cheques for the OSC
- 2.5. The International Night Chair shall:
 - 2.5.1. Be responsible for coordinating and running the annual International Night Show which acts as a showcase for OSC clubs.
