# 7. DEPUTY PRESIDENT (FINANCE & SERVICES) REPORT

RECEIVED: The report was presented by the Deputy President (Finance & Services)

### NOTED:

- a) The online budget submission process went extremely well.
- b) College have indicated that there will be an across the board 5% reduction in all departments subvention.
  - i. The Central union are hopefully able to absorb this but this is being discussed at the next meeting of the Executive Committee.
- c) Hoping to serve Fairtrade wine and spirits at the Summer Ball.
- d) Club bribery is being using used during the Sabbatical and Trustee elections.
  - i. Hustings will be taking place on the Tuesday lunchtime and the Thursday evening with 'free' beer being provided in the evening's events.
- e) The Union currently has approximately £1m invested with College which is receiving 1.5% interest and £1.1m cash in bank.
- f) College have offered to pool the Unions cash in their account but the long term benefit needs to be looked in to.
  - i. This will be looked in to at the next meeting of the Trustee Board.
- g) Council moved to a vote to accept the report and it was accepted unanimously.

## 8. CITY AND GUILDS COLLEGE UNION REPORT

RECEIVED: The report was presented by the City and Guilds College Union President

## NOTED:

- a) The reason for the report not being submitted to the last meeting was due to a massive academic commitment for the City and Guilds College Union President.
- b) The City and Guilds College Union President stated that he would very much like to dedicate more time to the Outreach programmes this term but academic commitments are restricting this.
- c) It is anticipated that the Masquerade Ball will break even.

# 9. AXE THE BEER TAX – SAVE THE PUB

RECEIVED: The motion was presented by the Welfare Campaigns Officer

### NOTED:

- a) It was questioned if the paper presented was ultra vires.
  - i. The Deputy President (Finance & Services) stated that in his opinion he believed that paper to be political and not affecting students as students and as such should not be discussed.
  - ii. The Welfare Campaigns Officer stated that we have a responsibility to the students that are at Imperial College and this issue does affect them outside of College as well as in the Union bars.
  - iii. The Deputy President (Clubs & Societies) stated that there are students at Imperial College that do not drink and as such does not affect them of which the Welfare Campaigns Officer stated that not all students get involved in Union activity.
- b) It was questioned as to what supporting this campaign would require for time and resources of students.

- The Welfare Campaigns Officer stated that CAMRA and the British Beer & Pub Association will be doing the majority of the work.
- c) The Deputy President (Finance & Services) pointed out that students pay tax on everything.
  - i. The purpose of the campaign is to make the taxes in pubs and supermarkets comparable as currently they are grossly disproportionate.
- d) The City and Guilds College Union President suggested amending the paper to reflect that Imperial College has 2 MP's that can be written to; Mark Fields and Malcolm Rifkin.
  - i. This was accepted by the Welfare Campaigns Officer.

#### **RESOLVED:**

1) Resolve 3 to now read:

'To write to the Mark Field and Malcolm Rifkin MP, informing him of our support for the campaign and encourage him to support the campaign.'

- e) The SCC Chair suggested to strike Union believes 2 as the pub is not a key experience for all Imperial College students.
  - i. The Welfare Campaigns Officer amended the point to remove the word 'key' and reflect that it is an experience for some students and not all.

## **RESOLVED:**

2) Union believes 2 to now read:

'That having a safe and comfortable social space such as a public house is a component to the student experience to some students at Imperial.'

f) Council moved to a vote to accept the amended paper and the votes are as follows

### **RESOLVED:**

- 3) That this Union should support the Axe The Beer Tax Save The Pub campaign and it's five key objectives:
  - a. To stop plans to increase beer tax by up to a third.
  - b. To enforce existing laws not create new ones to deal firmly with irresponsible drinkers and premises.
  - c. To end the irresponsible promotion of alcohol in supermarkets, pubs and elsewhere.
  - d. To trust responsible adults to make informed choices about what they drink, not punish them for the actions of an irresponsible minority.
  - e. To support the British pub as a vital part of social life in local communities.
- 4) That this Union should actively promote the campaign through free resources provided by the campaign's founders, appearing as a supporter on <a href="www.axethebeertax.com">www.axethebeertax.com</a> and providing a link to the campaign from our website.
- 5) To write to the Mark Field and Malcolm Rifkin MP, informing him of our support for the campaign and encourage him to support the campaign.
