ANNUAL BUDGETING - MINIMUM FUNDING LEVELS

Background

In the past there has been a funding model for the CSCs/FUs which guaranteed 80% of the previous years funding less their underspend from that year. In 06/07 this changed to 75% and then in 07/08 changed back to 80%. In 08/09 CSB voted to keep the minimum funding levels at 80% despite the DPFS advising to lower the level to 60%.

This year I am proposing three models for discussion which can be seen in the table below. Model A guarantees 60%, Model B 70% and Model C 80%.

There is a flaw with a guaranteed funding model; if a particular CSC is over funded and another underfunded it is difficult to adjust for any change (especially with such a high percentage of guaranteed funding). A CSC could be overfunded for many reasons, one strong reason which can easily be discussed diplomatically is its number of dead clubs and the same story is true for an underfunded CSC who has had a lot of new additions that year.

ICU will be cutting Clubs and Societies grant funding by at least 5% this year (and this figure is likely to be 10%) due to the cut we will be receiving in our subvention from college. This is why I suggest lowering the minimum funding level to 60% less underspend and have the remaining 40% allocated in the annual CSB Budgeting Round. The downside to this, is the meeting will inevitably take much longer than usual, I think it is worth the sacrifice in order to make the system much fairer and if you believe your CSC/FU really deserves the same amount of funding as last year then you will stay and fight for it.
