The agenda was changed to consider tour applications as the first item of business

1. TOUR APPLICATIONS

1.1 Media Photography

NOTED:

- a) Original idea came from last summer's Tour application but due to change in committee this did not happen.
- b) It is the same idea as before just now to be run at Easter
- c) It was agreed that the Board voted on the validity of the tour based on the proviso that when the students return they are to produce an exhibition of the photos that have taken.

RESOLVED:

- 1) To accept the Media Photography tour application as valid on the proviso that the club puts on an exhibition of the photos taken on the Tour.**

1.2 ACC Golf

NOTED:

- a) The tour is based on travelling to Portugal to play against three other clubs in three days.
- b) The tour allows people of all abilities to attend.
- c) The board moved to a vote on approving the tour as valid and it was passed unanimously.

RESOLVED:

- 1) To accept the ACC Golf tour application as valid**

1.3 ARTSOC

NOTED:

- a) 4 days 3 nights
- b) Same amount as previous year
- c) It was agreed that the Board voted on the validity of the tour based on the proviso that at least 2 cultural visits are done each day

RESOLVED:

- 1) To accept the Art Soc tour application as valid on the proviso that at least 2 cultural visits are done each day**

1.4 A CAPELLA

NOTED:

- 1) They had a successful Tour to USA last year based on the same idea as this time – will base it in the UK instead.
- 2) This is an audition level Tour
- 3) It was agreed that the Board voted on the validity of the tour based on the proviso that all members can have the chance to go and this is advertised. Also they need to put on one workshop/event per day

RESOLVED:

- 1) To accept the A Capella tour application as valid on the proviso that all members can have the chance to go and this is advertised. Also they need to put on one workshop/event per day**

1.5 CATHOLIC

NOTED:

- a) This will be open to all members who wish to attend
- b) They have had other successful events this year so far
- c) The board moved to a vote on approving the tour as valid and it was passed unanimously

RESOLVED:

- 1) To accept the Catholic tour application as valid.**

1.6 CAVING

NOTED:

- a) They are going abroad as the UK does not offer the same caving system
- b) They do not require as much clothing due to the warmer weather
- c) The board moved to a vote on approving the tour as valid and it was passed unanimously

RESOLVED:

- 1) To accept the Caving tour application as valid.**

1.7 CHAMBER

NOTED:

- a) This is the same style Tour that happens each year just in a different part of the UK
- b) It is all workshop based with a Show at the end
- c) The board moved to a vote on approving the tour as valid and it was passed unanimously

RESOLVED:

- 1) To accept the Chamber tour application as valid**

1.8 CHEERLEADING

NOTED:

- a) They have not budgeted for this competition due to having more members than anticipated this year
- b) It is a two day competition this year rather than one so this has more costs
- c) Any club member can go along and enter
- d) The board moved to a vote on approving the tour as valid and it was passed unanimously

RESOLVED:

- 1) To accept the Cheerleading tour application as valid.**

1.9 CIVIL ENGINEERING

NOTED:

- a) They usually go to Europe each year
- b) BP has reduced their budget from last year so they need to apply for more funding
- c) They have planned site visits with local Universities
- d) It was agreed that the Board voted on the validity of the tour based on the proviso that at least 2 site visits are done each day

RESOLVED:

- 1) To accept the Civil Engineering tour application as valid on the proviso that at least 2 site visits are done each day**

1.10 CYCLING

NOTED:

- a) The club has seen a growth in numbers this year
- b) The minibus will be used as a support vehicle and to be used on the return
- c) The route is ambitious but beginners can use the support vehicle
- d) The board moved to a vote on approving the tour as valid and it was passed unanimously

RESOLVED:

- 1) To accept the Cycling tour application as valid.**

1.11 FELLWANDERS

NOTED:

- a) Spending the days hiking but there is one days rest to go to Inverness for supplies
- b) The board moved to a vote on approving the tour as valid and it was passed unanimously

RESOLVED:

- 1) To accept the Fellwandlers Tour application as valid.**

1.12 ICE HOCKEY

NOTED:

- a) Both teams have not gone in previous years, they now want to take both
- b) The Tour has been rejected due it not meeting the Tour policy requirements

RESOLVED:

- 1) To reject the Tour application**

1.13 ICSMSU FOOTBALL

NOTED:

- a) All medic schools compete in the competition
- b) They can add more numbers as spectator tickets can be bought
- c) It was agreed that the Board voted on the validity of the tour based on the proviso that all spectators or members that are not picked can participate in prearranged smaller matches

RESOLVED:

- 1) To accept the Football tour application as valid on the proviso that all spectators or members that are not picked can participate in prearranged smaller matches with other groups attending**

1.14 LEOSOC

NOTED:

- a) This Tour is to increase the club members appreciation in art and improve their art skills
- b) It was agreed that the Board voted on the validity of the tour based on the proviso that each day there are 2/3 museum or gallery visits or the expected one day art class with the Berlin tutor

RESOLVED:

- 1) To accept the LeoSoc tour application as valid on the proviso that each day there are 2/3 museum or gallery visits or the expected one day art class with the Berlin tutor**

1.13 OUTDOOR

NOTED:

- a) Dates are dependent on members going on the Tour
- b) There are different levels available for different abilities
- c) It was agreed that the Board voted on the validity of the tour based on the proviso that more than one activity is available to members.

RESOLVED:

- 1) To accept the Outdoor tour application as valid on the proviso that more than one activity is available to members**

1.14 PARACHUTE

NOTED:

- a) This is a competition level Tour with the dates not yet published but around 3rd-6th May
- b) This is during Term time but they will not stay for the whole predicted dates
- c) They have a lot of members who are trained to the level required but the rest who are not do have the time do get to the level before the Tour
- d) The board moved to a vote on approving the tour as valid and it was passed unanimously

RESOLVED:

- 1) To accept the Parachute tour application as valid**

1.15 SYCRONISED SWIMMING

NOTED:

- a) There are no UK competitions available here
- b) There will be a training session arranged with a local University
- c) There is also the chance to do some open water swimming
- d) The board moved to a vote on approving the tour as valid and it was passed unanimously

RESOLVED:

- 1) To accept the Synchronized Swimming tour application as valid**

1.16 UNDERWATER

NOTED:

- a) Tour based on going to Iceland
- b) Offers different diving conditions
- c) The board moved to a vote on approving the tour as valid and it was passed unanimously

RESOLVED:

- 1) To accept the Underwater tour application as valid**

1.17 CYPRIOT

NOTED:

- a) This Tour had not been submitted on time due to member completing the form being ill from College and missing some of his exams so missed the deadline by 3 days

RESOLVED:

- 1) To consider the application for the Tour**

- a) It is a culture experience trip to take in the sights and offer culture to the locals
- b) There is the option to take all members if they wish as they have a wider network of members than just Cypriots
- c) The board moved to a vote on approving the tour as valid and it was passed with 3 abstentions

RESOLVED:

- 1) To accept the Cypriot tour application as valid**

2.0 SILWOOD TOURS

2.1 SILWOOD CLIMBING

NOTED:

- a) This is a Tour to France
- b) The board moved to a vote on approving the tour as valid and it was passed unanimously

RESOLVED:

- 1) To accept the Silwood Climbing tour application as valid**

2.2 SILWOOD DIVING

NOTED:

- a) The Undergrad tour offered with the South Ken trip wouldn't be possible for the Post Grads at Silwood so these dates suit the members better
- b) The board moved to a vote on approving the tour as valid and it was passed unanimously

RESOLVED:

- 1) To accept the Silwood Diving tour application as valid**

2.3 SILWOOD ESCAPE

NOTED:

- a) Revival of previous years activities as the club has been previously dormant
- b) Not a normal tour application but the policy states this can happen for a first year club
- c) The board moved to a vote on approving the tour as valid and it was passed with 2 abstentions and 1 rejection

RESOLVED:

- 1) To accept the Silwood Escape tour application as valid**

2.4 SILWOOD NATURAL HISTORY

NOTED:

- a) This Tour would allow for more PhD and Masters students to gain more field experience
- b) The board moved to a vote on approving the tour as valid and it was passed with 2 abstentions

RESOLVED:

- 1) To accept the Silwood Natural History tour application as valid**

2.5 SILWOOD PHOTOGRAPHY

NOTED:

- a) There is a competition coming up at Silwood for photographers and this Tour would help.
- b) It was agreed that the Board voted on the validity of the tour based on the proviso that when the students return they are to produce an exhibition of the photos that have taken

RESOLVED:

- 1) To accept that Silwood Photography tour application as valid on the proviso that the club puts on an exhibition of the photos taken on the Tour**

3.0 MOUNTAINEERING

NOTED:

- a) This is good experience for the newer members to have extra training as some of the more experienced members will be leaving this year
- b) The location allows flexibility for those that want to leave early to get back for revision
- c) Silwood are proposing a similar trip so discussions need to happen between Silwood and Mountaineering.

RESOLVED:

- 1) To accept that Mountaineering tour application as valid**

4.0 *Boat, Canoe and Wakeboarding were not present at the meeting and as such were considered at the end of the tours discussion.*

4.1 BOAT

NOTED:

- a) This is an annual event and as such is not a valid tour application
- b) The tour is rejected as it does not meet the tour policy requirements

RESOLVED:

- 1) To reject the tour application**

4.2 CANOE:

NOTED:

- a) Will travel in minibuses in order to take equipment
- b) Only grades 3/ 4 are advised to attend
- c) Tour application must be available to every member. However, it is possible for a member to reach the required level before the tour
- d) It was agreed that the Board voted on the validity of the tour based on the proviso that beginners were given the training opportunities to reach the required level and that the club had an acceptable reason for not attending the meeting.

RESOLVED:

- 1) To accept that Canoe tour application as valid on the proviso that beginners were given the training opportunities to reach the required level and that the club had an acceptable reason for not attending the meeting.**

4.3 WAKEBOARDING:

NOTED:

- a) Tour to Plymouth at end of the spring term
- b) It was agreed that the Board voted on the validity of the tour based on the proviso that the club had an acceptable reason for not attending the meeting.

RESOLVED:

- 1) To accept that Canoe tour application as valid on the proviso that the club had an acceptable reason for not attending the meeting.**

5.0 ANNUAL BUDGETING – MINIMAL SPENDING LEVELS:

NOTED:

- a) The principle reason for lowering the minimum guaranteed % levels is increase flexibility and the opportunity for change
- b) There should be a guaranteed level, primarily as an insurance policy
- c) The higher the minimum allocation percentage the more difficult it will be to fairly re-distribute funds.
- d) It was agreed that the board would vote on a minimum 70% allocation (less previous years underspend) on the proviso that the 70% would be minus any grant from terminated clubs.
- e) This proposal was rejected based on 6 votes against, 5 for, 3 abstains.
- f) It was agreed that the board would vote on a minimum 80% allocation (less previous years underspend) on the proviso that the 80% would be minus any grant from terminated clubs with the amendments of taking grant and underspend then take 80%.

RESOLVED:

- 1) To accept the agreement on the proviso that the 80% would be minus any grant from terminated clubs with 6 votes for, 4 against and 4 abstains

6.0 CAG REPORT:

NOTED:

- a) A few clubs have not submitted all of the required documentation. CAG Exec are speaking to them.
- b) No major issues amongst projects

RESOLVED:

- 1) The CAG report was accepted

7.0 RCSU REPORT:

NOTED:

- a) Dep socs have produced successful events so far this year
- b) No major issues to report

RESOLVED:

- 1) The RCSU report was accepted

8.0 MINUTES OF LAST MEETING – 11th December 2012

NOTED:

- a) One amendment required: the RCC Chair was present at the meeting; the Silwood Park Union Representative was unable to attend via a Skype link.

RESOLVED:

- 1) To pass the minutes of the last meeting with this amendment

7.0 ANY OTHER BUSINESS

NOTED:

- a) CSP policy to be sent out again by DPCS with corrections made
- b) New features of eactivities sent out in e mail
- c) Minibus price rise to go to exec with minimum of 5% proposed.
- d) Budgeting training is taking place Thursday lunchtime (24/01/13)
- e) Tours policy needs an update, deadline still to come – members asked to think on any issues and problems and forward them to the DPCS and DPFS.
- f) Request for Silwood and motor club to present first at the budgeting meeting due to length of return journey.
