1. HIGHER EDUCATION POLICY PRESENTATION

RECEIVED: The presentation was made by the Education & Welfare Manager Andrew Keenan

NOTED:

2. CHAIRS BUSINESS

NOTED:

- a) The meeting was deemed inquorate and as such no decision can be made.
 - i. The papers will be discussed with recommendations to be made to Council.
- b) The Union Awards nominations will be opening soon and Council members will be contacted to sit on the committee.

3. MINUTES - 11.03.14

RESOLVED:

- 1) To recommend to pass the minutes as an accurate record of the meeting.

The agenda was reordered at this stage to consider agenda item 6 as the next item of business

6. MOTION FOR IMPERIAL COLLEGE UNION TO SAY NO TO ISLAMOPHOBIA AND DENOUNCE 'STUDENT RIGHTS'

RECEIVED: The paper was presented by Hazem El-Turk

NOTED:

- a) The effect on Imperial has already been tested as an event where a speaker came to talk to Isoc was sensationalised on the Students Rights website.
 - i. Isoc engaged with the Union and College prior to the event to ensure that all the processes and procedures were followed and the event went ahead with no issues.
- b) The majority of the Student Rights website is currently populated with anti-Muslim articles.
- c) Student rights directly target SU's and the paper is asking for the Union to have a plan in place if they contact ICU.
- d) Council moved to a vote to recommend the paper and the vote is as follows:

FOR 20 AGAINST 0 ABSTAIN 2

RECOMMENDATION: To pass the presented motion for Imperial College Union to say no to Islamophobia and Denounce 'Student Rights'

The Union Resolves:

- 1) Imperial College Union release a public statement/open letter addressed to Student Rights criticising their lack of transparency, sensationalism, divisive and counter-productive activities and disproportionate preoccupation with Muslim students, and calling on them to drastically change their approach and mentality. The statement should also outline ICU's commitment to challenging Islamophobia along with all other forms of prejudice and discrimination, and should be circulated to students so that they too are aware of the stance and feel reassured if necessary.
- 2) Imperial College Union to write to Imperial College management, making explicit students' concerns about the effect Student Rights' activities have on students' welfare, campus cohesion and freedom of speech on campus, as well as reiterating the Union's desire to maintain its autonomy in determining guidelines on external speakers in co-operation with College, without outside interference.
- 3) Imperial College Union to maintain ongoing communication with College regarding any developments, including asking College and the Press Office to inform ICU of any future

attempts by *Student Rights* to lobby them regarding any student group's activities. In the instance that the latter occurs, ICU is to keep the concerned societies' leadership informed about the situation without delay.

5. COUNCIL ADVOCACY PROCEDURE

RECEIVED: The paper was presented by the A&E Chair

NOTED:

- a) The purpose of the paper is to create a forum where the interested parties meet to discuss and put forward a recommendation to Council.
- b) The group can invite other members of Union to be part of the committee.
- c) It is not a policy making body it will be making recommendations.
- d) The motivated people will volunteer to be part of the committee which in theory are people that will be making the majority of the discussion in Council.
- e) It was suggested that Annual General Meetings should be utilised more and embed it as a culture of the Union.
- f) A working group is undefined and has no reporting structure. The Advocacy Procedure will formalise the procedure and structure. The Advocacy group will focus on debate of the issue rather than a working group which is more of a 'doing' group.
- g) It was queried as to what would happen if the recommendation made by the Advocacy Group is challenged in Council and the procedure does not allow debate.
 - i. The A&E chair stated that there needs to be a good reason for the recommendation to be challenged or for the topic to be debated again, such as a Council member not being present at the Council meeting due to valid reason.
- h) Effective chairing of Council should not allow circular debates.
- i) It was highlighted that the Advocacy group may not draw consensus and then the recommendation will automatically lead on to further debate at the next meeting which negates the purpose of the group.
- j) The guidelines for the Advocacy Group and how the debate will be run have not been drawn up to allow for flexibility in how the group will meet.
- k) There is a risk of the perception of decisions being made by a small group which negates the representative function of Council.
 - i. It was reiterated that the Advocacy Group will be recommending decisions.
- It was highlighted that the time commitment on volunteers is already pressured and by it is unfair to out further time commitments on volunteers.
- m) The Deputy President Clubs & Societies stated that Council is already perceived as a barrier to students and that the language used on the proposed policy is yet another barrier which doesn't make it acceptable or welcoming to members not involved in the Union.
- n) It was suggested that Council should be promoted and if students are interested on the topics being discussed, then they will attend the meeting to be able to get their opinion across.
- The Advocacy Group will attract the same people who vocalise their opinion in all council meetings.
- p) Council moved to a vote on recommending to pass the presented paper and the vote is as follows:

FOR 4 AGAINST 10 ABSTAIN 8

RECOMMENDATION – Not to pass the Council Advocacy procedure

7. STUDENT CONSULTATION FRAMEWORK

RECEIVED: The paper was presented by the President

- a) The changes made in the document compared to when it was presented to the last council are not dramatic. The document gives more detailed guidance on consultation.
- b) Big College decisions get an award and departments will use it as a working tool.

- c) It was suggested that departments won't use it and it was highlighted that they can be forced to. Hopefully peer pressure from other college departments will encourage it to happen.
- d) Consultation far reaching and by that token, it is hoped that those consulted will ensure that it will happen.
- e) Training on how students can use the system will be added to training.
- f) Student consultation has been in the form of Union meetings; Felix and publishing in the Union Newsletter and student have feed in through these routes.
- g) A few minor typographical errors were pointed out.
- h) Council moved to a vote to recommend the Student Consultation Framework and the vote is as follows:

FOR 18 AGAINST 2 ABSTAIN 3

RECOMMENDATION: To pass the presented Student Consultation Framework.

8. PRESIDENTS REPORT

RECEIVED: The report was presented by the President

NOTED:

- a) It was questioned as to why Executive Committee hasn't been meeting.
 - It was stated that the decisions that were need to be made were for event budgets of which the decisions could be made over email and not requiring a physical meeting. All decisions are reported to the next meeting of the Executive Committee.
 - ii. The Deputy President (Finance & Services) stated that he will provide a summary of Event Budget decisions made by Executive Committee to the next meeting of Council.

ACTION:

- 1. The Deputy President (Finance & Services) to supply a summary of Executive Committee decisions that have made over email.
- b) Council moved to a vote on recommending accepting the report and it passed unanimously.

9. DEPUTY PRESIDENT (CLUBS AND SOCIETIES)

RECEIVED: The report was presented by the Deputy President (Clubs and Societies)

NOTED:

- a) The noising demolition work in the basement has not finished.
 - i. The Union offered quite study space away from the works however it was deemed not required by Phil Noteley as the library was open.
- b) Council moved to a vote on recommending accepting the report and it passed unanimously.
