## **B-278-650-1 UNICEF**

a) It is noted that UNICEF are asking for funding for fundraising, which is against charity law and therefore not allowed.

## A-765-685-1, A-765-640-1, A-765-895-1 Soup Run

- a) It is noted that Soup Run receive 100% funding
- b) The CAG Chair notes that Soup Run is a self-run project and that without the funding they would not be able to run the project at all
- c) It is noted that Soup Run has been funded to 100% in previous years.
- d) It is noted that every other society who hires minibuses and purchases consumables does not get funded to 100%.
- e) It is noted that the majority of projects get funding from the IC Trust.
- f) It is proposed that Soup Run look for sponsorship.
- g) It is proposed that CSPB fund Soup run's drinks supplies at £7.70p per member and fund minibuses like every other club.
- h) It is proposed that CSPB fund Soup Run 2/3rds of the top up request of the travel line **A-765-895-1.**
- i) The board moved to a vote to accept the proposed changes.

### A-403-735-1 Choir

### A-658-640-1 ICSMSU Badminton

- b) This has been taken into consideration and the board is happy to move back to the original request.

### A-658-710-1 ICSMSU Badminton

- a) It is noted that ICSMSU Badminton have not justified why they cannot charge more for membership to cover the cost of court hire.
- b) It is noted that if the hours are cut down for social members, less people will join and participate.

### A-658-605-1 ICSMSU Badminton

- a) It is noted that not funding to the requested amount would lead to a large decrease in participation
- b) It is noted that the club did not give good enough justification in their budget.
- c) It is suggested to come back to this later.

### **ACC**

## A-0-895-1 ACC Exec

- a) It is noted that the ACC Exec has paid for coaches to send the Freshers to Harlington for sports trails
- b) It is noted that this was previously funded to 100% but was cut to 40% last year
- c) It is noted that this helps increase participation for all clubs and helps fresher's get engaged in sport
- d) It is proposed to fund this to 50%
- e) The board move to a vote to accept the proposal

### Resolved:

a) The vote passes with two abstentions

### A-6-605-2 Boat

- a) It is noted that the activity is very expensive
- b) It is noted that Boat have not submitted a very good budget, with only two A-lines submitted
- c) It is noted that rowing is one of the best in the country and people come to Imperial to row
- d) It is noted that it costs £1500 per person to row for Imperial College
- e) It is proposed to top up to £3851.2
- f) The board move to a vote to accept the proposal

### Resolved:

a) The vote passes with 1 abstention and with the recommendation that Boat put more effort into their budget next year

# A-46-710-1 Archery

# A-10-710-1 Fencing

# A-27-710-1 Swim & Water polo

- a) It is noted that this is an expensive sport
- b) It is noted that swimming is free at ethos so there is less of an incentive to join the club
- c) It is noted that water polo is external and not covered at ethos
- d) It is suggested to top up to £2500

# A-3-710-1 Badminton

- a) It is noted that Badminton asked for ground hire funding at 80% but received 0%
- b) It is proposed that Badminton are funded at the ground hire percentage of 23%
- c) This proposal is accepted

#### A-11-605-1 Golf

- a) It is noted that Golf is a very expensive activity.
- b) It is noted that paying for Golf Club membership might not mean that they would actually play golf.
- c) It is proposed to top up at £300

## Resolved:

a) This top up was agreed by the ACC Chair.

## A-147-680-2 Cheerleading

- a) It is noted that grant for this category from last year has not been touched
- b) It is noted that the competition hasn't happened yet
- c) The board were not convinced by this justification and therefore rejected the top up

## A-39-710-1 / 2 / 3 Riding & Polo

- a) It is noted that this activity is very expensive and should be capped at £100 as with all other expensive activity as agreed in CSPB-A.
- b) It is suggested to raise the membership target as it is low.
- c) It is proposed to top up £550
- d) The board moved to a vote to accept the proposal

#### Resolved:

a) The proposal passes with 2 abstentions.

### ICSMSU Badminton A-658-710-1

- a) It is noted that court hire has increased from last year
- b) It is proposed to top up at £67

#### **ICSMSU Boat A-660-685-2**

### ICSMSU Football A-656-895-1

a) It is noted that ICSMSU Football receives 60% less funding than ACC Football, who also get coaches

- b) It is noted that the club are having to turn away members
- c) It is noted that the club has increased membership by 50%
- d) It is noted that the board were not convinced with these arguments
- e) It is suggested to top up the line to £450
- f) The board moved to a vote to accept this suggestion
