## 1. COLLEGE TIMETABLING POLICY

## RECEIVED: A presentation was given by John Crooks (Head of Timetabling)

NOTED:
a) The timetabling policy will evolve over the next few years but the College is looking to implement changes over this time.
b) Traveling in between lectures as well as campus needs to be a consideration.
c) Global events such as Varsity and RAG should be considered when timetabling.
i. Religious observations are already a consideration.
d) It was suggested that lectures should run to a 45 minute teach time with 15 minutes being utilised for rest and travelling before the commencement of the next lecture.
e) Teaching in the evening should be clustered to minimise energy impact.
f) The system that ESE uses at present was suggested as a best practice example however it was stated that this system is not scalable.
g) It was recognised that there needs to be buy in across all departments which is one of the challenges that is being faced.
h) Exams are currently omitted from the policy but this should be a consideration.
i) It was stated that the current teaching day will not be extended.
j) The policy does not capture room usage by CSP's.
