- a) Currently the Union does not pay the London Living Wage
- b) The jobs section of the website states that wages for casuals start from £6.50 which suggests that the website needs updating to reflect the increase in minimum wage for over 21's.
- c) Anecdotally students undertake casual work to supplement the other sources of income rather than rely on that income as a primary source.
- d) The Deputy President (Finance & Services) was mandated to invite members of Union Council to form a working group to investigate the options and impact of the Union implementing the London Living Wage.
