Union Notes

- 1. The role of Deputy President (Finance & Services) has long been established and oversees financial procedure within the Union.
- 2. The role of Deputy President (Clubs & Societies) has long been established and oversees Club and Society, processes and facilitation within the Union.
- 3. The work of the Officer Trustees should be strategic to input the student voice in all areas of College and the Union rather than operational and working on repetitive tasks with almost no student impact.
- 4. The Job description of the Deputy President (Finance & Services) was amended two years ago to make it more strategic this has not been implemented.
- 5. The Job description of the Deputy President (Finance & Services) is focussed heavily on Union functions.

Union Believes

- 1. An accurate job title and job description are crucial to attracting the best candidates most interested in the role at election time.
- 2. Current Officer Trustee roles and role descriptions do not match up with the work that is actually being done.
- 3. The role of the Deputy President (Clubs & Societies) is not reflected in the role title and is not fully reflected in the Job Description.
- 4. Having oversight of all Union and student facing College functions is of the utmost importance.
