01	Welcome & Introductions	The Council Chair welcomed everyone to the meeting and everyone introduced themselves.
02	Apologies for Absence	Apologies received for the meeting in advance were noted as above.
03	Standing Orders	The Council Chair presented the Standing Orders as last approved by Council in June 2022 and Council noted their contents.
04	Scrutiny Committee Membership	<p>The Council Chair noted that four volunteers from Council will need to be chosen to serve on Scrutiny Committee, once the full membership of Council has been elected following the Autumn Elections. The Council Chair asked interested parties to contact her for more information.</p> <ul style="list-style-type: none"> i. CC asked how the change to introduce Scrutiny Committee came about. The Union President explained that it was a recommendation of the Democratic Structures Review undertaken by last year's Union President and a working group, noting that Council agreed the recommendation by voting to amend the Standing Orders at the last meeting. ii. CC asked if this year's Union Council has to continue with the Scrutiny Committee arrangement, if it was agreed by a previous incarnation of Council. The Union President suggested trailing the arrangement for one academic year and then reviewing it after one year. iii. AH asked if you can stand for Scrutiny Committee if you are not on Council. The Council Chair noted that the Standing Orders imply that the Scrutiny Committee membership is drawn from voting members of Council.
