#### **ACC General Meeting Minutes**

#### Minutes

1. Apologies – non received.

#### 2. Chair's Business -

- a. Grant Re-allocation and Triathlon contingency claim:
  - i. It became clear that at the end of the last academic year, some clubs had their grants moved to their SGI, some clubs' grant was absorbed into the Union finances.
  - ii. Triathlon had £328.40 left in their grant which was absorbed into the Union finances.

# Athletics Clubs' Committee Report of the Year – Treasurer A Letter by Chew Shen Liew - ACC Treasurer

Dear ACC Club members,

This year, significant improvements to e-Activities have resulted in a reduction of transactional difficulties faced by clubs. It is very encouraging to see increased familiarity to the online financial system that was introduced two years ago. In order to ensure that treasurers were equipped with basic e-Activities and financial knowledge, I initiated a training session in October. Despite its lower than expected attendance, I propose the continuation of this session for the benefit of those who are interested next year.

The total ACC budget for the year 2013/2014 will be £135,866.26, down 2% from previous year. A cut was observed in most Management Groups with CGCU and SCC taking the largest cuts of over 30% each. ACC fared relatively well due to good and reasonable budgets submitted by most clubs. We had to take many tough decisions but Jake and I tried our best to ensure that the grant was fairly distributed among all clubs.

As the ACC Treasurer, my day-to-day responsibilities included approving transactions that are sufficiently funded and are supported by proper documentations. To date, a total of over 1,000 transactions were submitted online by all 53 ACC Clubs, recording a combined turnover of around £430,000. I worked very closely with the Union finance team to deal with extenuating financial cases and claims. I was also responsible for ensuring the financial health of clubs and identifying clubs that are in debt or struggling. Jake and I were then able to offer further support to these clubs.

Before I step down as Treasurer, I would like to thank all ACC Club committees and members whom I have worked with for your patience and for giving me a great learning opportunity. I wish you the best of luck in your future endeavours.

## Athletics Clubs' Committee Report of the Year – Chair A Report by Jake Woods - ACC Chair

This year has been both a great success and shown great difficulty to the ACC. The closure of Wilson House has seen several clubs with poor substitutes for trainings venues and as a direct result have seen their clubs suffer. Additionally the ever increasing participation in sports as a whole has seen high impacts on the availability of facilities, Squash and Badminton in particular can testify to this. On the other hand increased support from the Union staff has meant that most issues within the ACC have been resolved swiftly. Plus we beat the Medics at Varsity once again.

Yet again the ACC has received a cut in budget, albeit the smallest for several years, I am firmly opposed to the current process and several meetings have been planned for the summer term to hopefully go some way to resolving these.

In each of these meetings I have been outspoken about the problems that could affect the ACC or individuals of ICU as a whole; in particular the lack of student focus in the Union bars resulting in the creation of the monthly deals amongst others. My suggestions have been logged with both the Union bar staff and the Commercial Services team; hopefully some of the changes will come into effect with the continued support of the next ACC Chair and DPCS. The Sport Imperial meetings have been a great opportunity to fix the problems you have spoken to me about, missing equipment, small improvements etc. Throughout the year I have made changes to the ACC, its processes or anything else I deemed incorrect, hopefully these have been beneficial for the people affected

The Sport Imperial 'merger' between IC and the Medics has finally happened this year, the consequences of which are currently unknown but likely to centre on space allocations and priorities between the two management groups. No actual merger between the teams is likely however the new BUCS ruling has decreed that IC and Medics must now compete under the same institution.

I would like to wish the next ACC Executive committee the very best of luck next year and I hope the clubs within the ACC continue to compete and succeed in each of their individual competitions.

### Athletics Clubs' Committee Membership Reduction Request – Volleyball

#### **Summary**

Volleyball Club currently has 28 members and the club's membership target is 45. The club asks for the membership target reduction to 35 members.

#### Background

Membership target of 45 has been met in the past 3 years. This year's problems are caused by the Wilson House Sports Hall closure. In the past years we trained on Wednesdays and Fridays, however this year we were forced to have the majority of our training sessions on Saturdays at the new venue provided by Sport Imperial. In result, many of our beginners decided to resign from Volleyball sessions, because they were unable to train during the weekends. Unfortunately, there were no other free timeslots that we could use.

The reduction to 35 members would allow us to receive £822. This money is needed to pay for the sports hall rental in the spring term. The club has already cancelled several training sessions to cut the costs.

#### *Matters for Decision:*

To reduce Volleyball Club membership target to 35.
