Request for the Approval of the Changes to the RCS MC Constitution as Passed by the RCS Motor Club's Annual General Meeting held on 20th March 2013

Following the changes to the Imperial College Union's Constitution and Bye-Laws part of our constitution was found to no longer conform to Union Regulation. At the Club's AGM this was rectified (see Annex A below). This change requires the constitution to be ratified by the RCC in accordance of point 81 of the Union's Clubs and Societies Policy (available online: <https://www.imperialcollegeunion.org/your-union/policies/44/file>).

In addition another small change to way the club elects its officers to better reflect the size of the club was made (Annex B) – in accordance with point 74 of the Clubs and Societies Policy.

As a consequence of these changes point 1.9 and 1.10 of the Constitution also required updating (Annex C).

Change from:

Section 8.3

The Chairman shall be the Returning Officer for all Club Elections, unless another Returning Officer is appointed by the Chairman. Any Returning Officer must either be a full member of the Club, or a Life Member of Imperial College Union.

Section 8.6

Prospective candidates must lodge their interest with the Returning officer, along with the names of a Proposer and two Seconders, at least five College days before the Annual General Meeting. In the event of an election at any other general meeting the five college days' notice is not required.

Prospective candidates must lodge their interest with the Returning officer, along with the name of a Secunder, at least five College days before the Annual General Meeting. In the event of an election at any other general meeting the five college days' notice is not required.

Change from:

Section 1.9

This Constitution took effect on 9th November 2012 after being passed by a General Meeting of the Club on 24th October 2012, and was ratified by the Recreational Clubs Committee on 8th November 2012

From 8th November 2012 all other constitutions of the Club are hereby revoked.
